Please find the following Coquetdale Community Message update covering the period from the 1st to the 29th December 2015

Thirteen (13) crimes were reported over this period:

### **Rothbury**

#### **Fraud by False Representation**

**(Rothbury)**

Occurred between 14/08/15 and 15/08/15

Victims pay offender for wedding entertainment which is not provided.
