Burglary Other Than Dwelling

(Simonside View)

Occurred 18.15 hrs Monday 11/01/16 where an insecure garage was entered, van keys removed from a coat pocket, with the offender making off in the occupants van.

The male occupant (victim) upon seeing his van being driven from the estate, followed after his stolen van in the family car but unfortunately did not have his phone.

The vehicle was followed to Scotswood Road, Newcastle and then made off.

The stolen vehicle then came to police notice due to involvement in a series of crimes, which included

a bilking, fail to stop for police and robbery.

Theses crimes occurred in the Newcastle East and South East Northumberland areas in the early hours of Tuesday morning .

A further police sighting of the stolen vehicle resulted in the male driver being detained, charged with 18 offences and remanded in prison, pending trial 10am 10/02/16 at Newcastle Crown Court. The male (28 yrs) is from the Newcastle East area with no specific connection to Rothbury.

Whilst the van was recovered, various tools within the vehicle had been taken.

Police stress the need to immediately contact police via the 999 telephone system if anyone appears suspicious or out of place.
