Please find the following Coquetdale Community Message update covering the period from the 1st to the 31st March 2016.

Eight (8) crimes were reported over this period:

Rothbury

Criminal Damage to shop window (Heart Made Home - Town Foot)

Occurred around midnight 16/03/16 when a traffic cone was thrown through a shop window causing damage to the window and stock.

Local male (17 years) interviewed and dealt with by way of community resolution with compensation £854 paid to the victim.

Burglary Dwelling (Rothbury area)

Occurred between 01/03/16 and 16/03/16 where unknown person enters a dwelling and removes money from a draw.

This incident came to light following continuing enquiries into recent similar incident in Rothbury. Police remind residents to be cautious in respect to persons accessing their homes, ensure homes are secure and report anything suspicious via 999.

CID enquiries are continuing.

Road Safety

Northumbria Police have a dedicated unmarked motor patrol vehicle deployed on the main arterial roads in the Alnwick area, which includes the A1, A697 and A696.

Police will focus on prosecuting dangerous driving, to ensure our rural roads are safe and prevent serious and fatal road traffic collisions.

Please drive carefully on the re-opened B6344 Crag End Road following repair and resurfacing. The twists and turns are inviting but present increased collision risks.

Community Speed Watch (CSW)

Our Community Speed Watch Volunteers have been providing a valuable contribution to preventing speeding in our towns and villages. Coquetdale Police and indeed our community are grateful for their time and dedication. Coquetdale have received a further 5 x CSW applications which are being progressed. Local deployment updates will be included in the next Community Message Bulletin.

Incident of Concern Simonside Hills, Rothbury

At around 12pm Good Friday 25th March, controlled burning on the Simonside Hills presented danger to the public resulting in a mother and daughter (11 years) suffering serious burns to face, hands and legs. The child was taken to hospital by the Air Ambulance and her mother by ambulance to the Newcastle RVI where they were both detained.

The Health and Safety Executive (HSE) are investigating this incident, supported by Northumbria Police and Northumberland Fire and Rescue Service. The area was frequented by many visitors and walkers at the time. HSE Inspectors are liaising with the land owner, to determine measures to prevent public risk.
